Hence, the Principal District Judges of the aforesaid nine districts are directed to take all necessary steps for operation and physical functioning of the Taluk Courts in their respective District w.e.f.04-06-2020 on the same pattern as the functioning of the Courts in the District Head Quarters, as directed in the reference cited Official Memorandum.
